**WHEREAS**, the Sangguniang Panlungsod enacted a City Ordinance No. CO 24-2014 entitled, "An Ordinance Consolidating City Ordinance No. 2013-020 Known As "Bacoor Senior Citizen Cinemas Discount Ordinance 2013 And City Ordinance No. 2013-021 Known As The "2013 Free Cinema Admission Ordinance For Disabled Citizens Of Bacoor" And Thereby Introducing Amendments Thereto", dated 04 September 2014.

**WHEREAS**, Mayor Strike B. Revilla signed a Memorandum of Agreement on behalf of the City Government of Bacoor with the SM Prime Holdings, Inc. dated 25 September 2014 pertaining to the "Libreng Sine" project of the city government for senior citizens and persons with disability pursuant to the City Ordinance No. CO 24-2014 and it was then submitted to the Sangguniang Panlungsod for ratification;

**WHEREAS**, the Sangguniang Panlungsod reviewed the said memorandum and unanimously decided to ratify the same.

**NOW THEREFORE**, upon motion of Hon. Reynaldo D.
