WHEREAS, the Sangguniang Panlungsod received a board resolution from the officers of the General Parents-Teachers Association of Bacoor National High School-Gawaran Annex requesting that the Bacoor National High School-Gawaran Annex be given "independent status" such that the said center for learning shall no longer be under the supervision of the Principal of the Bacoor National High School.

WHEREAS, after conducting a committee hearing on the said request, the Sangguniang Panlungsod discovered that there is no legal ground not to grant the said request. However, the Sanggunian has no power to grant the same;

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola, unanimously seconded by all the councilors present in regular session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to endorse the request of the officers of the General Parents-Teachers Association of Bacoor National High School-Gawaran Annex to the Department of Education (DepEd) to grant "independent status" to the Bacoor National High School-Gawaran Annex.

RESOLVED THAT, the DepEd and other government agencies/offices concerned shall be furnished with copies of this Resolution.

RESOLVED LASTLY, This Resolution shall become effective upon completion of its posting in at least (3) three conspicuous places in the City of Bacoor, Cavite and after it has been published once in a newspaper of general circulation within the Province of Cavite.
