A RESOLUTION WAIVING THE 30% SHARE OF THE CITY GOVERNMENT IN AMUSEMENT TAXES ON TWO (2) MOVIES TO BE SPONSORED BY THE PHILIPPINE NATIONAL RED CROSS (PNRC), CAVITE CHAPTER, WHICH WILL BE SHOWN AT SM CINEMA, BACOR, CAVITE ON DECEMBER 2014.

WHEREAS, on 25 September 2014, a letter request from the Philippine National Red Cross (PNRC - Cavite Chapter) was endorsed by the Office of the City Mayor to the Sangguniang Panlungsod to pass a resolution waiving the 30% share of the City Government in amusement taxes to be charged on two (2) movies which will be shown at SM Cinemas operating within the city on December 2014.

WHEREAS, PNRC (Cavite Chapter) will sponsor the exhibition of the said movies and proceeds thereof will become a trust fund of the city government specific for the blood needs of its constituents in the future.

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica duly seconded by Hon. Bayani De Leon in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to grant the request of the Philippine National Red Cross (Cavite Chapter) for the waiver of the 30% share of the City Government of Bacoor in amusement taxes to be charged on two (2) movies which will be shown at SM Cinema on December 2014. Provided, that the said movies chosen by the PNRC (Cavite) coordinated with the management of SM Cinemas operating within the city.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
