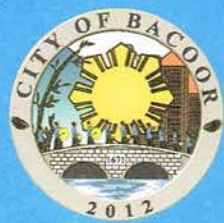
WHEREAS, Section 76 of Republic Act No. 7160 empowers local government units to design and implement its own organizational structure and staffing pattern.
