Revilla, to exclude drugstores, pharmaceutical establishments, medical clinics, dental clinics, veterinary clinics, and other similar establishments that does not produce hazardous waste from the implementation of the Memorandum of Agreement between the city government and the Association of Private Lying Ins, Inc.

RESOLVED LASTLY, to furnish the Bacoor Private Drugstore Owners' Association Inc., the Association of Private Lying Ins Inc., and all concerned government offices with copies of this resolution.
