A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN BARANGAY TALABA I AND BARANGAY TALABA VII, CITY OF BACOR, CAVITE AND AUTHORIZING THE RELEASE OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP 1,500,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR RELIEF AND REHABILITATION OPERATIONS.
