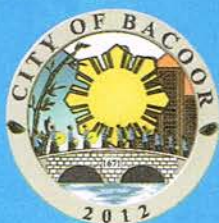

- 5) Repair and rehabilitation of Barangay Infrastructure and facilities;
- 6) Livelihood assistance to barangay constituents; and
- 7) Repair of school buildings and other educational facilities.

WHEREAS, the said request was deliberated upon by the city councils and it was unanimously decided upon to authorize the City Mayor to extend financial or material assistance to the Municipality of Jaro, Leyte subject to availability of funds and in strict compliance with government regulations regarding the same;






