A RESOLUTION REQUESTING MAYNILAD WATER SERVICES INC. TO TAKE OVER THE OPERATION OF THE WATER SYSTEM AT COASTAL WOODS SUBDIVISION DUE TO SERIOUS PUBLIC HEALTH AND SANITATION CONCERNS.

WHEREAS, a water potability test involving water samples taken by residents of Coastal Woods Subdivision revealed that the drinking water they are consuming is infected with coliform.

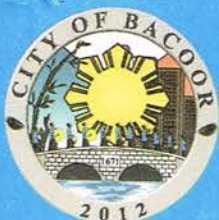
