**WHEREAS**, the City of Bacor owns several parcels of land having an aggregate area of 13, 103.04 square meters.

**WHEREAS**, various public schools were constructed – and would soon be constructed – on the said parcels of land.

**WHEREAS**, a draft Deed of Usufruct between the City of Bacor and the Department of Education (Division of Bacor City) for the perpetual use of the said parcels of land by the DepEd in a usufructuary capacity was submitted by the Office the City Mayor to the Sangguniang Panlungsod for the requisite review.

**WHEREAS**, the terms and conditions of the said Deed of Usufruct were deliberated upon by the Sangguniang Panlungsod and were found to be in accordance with law.

**NOW THEREFORE**, upon unanimous motion of the members of the Sangguniang Panlungsod comprising a quorum in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the City Mayor, Hon. Strike B. Revilla, to sign the Deed of Usufruct between the City of Bacor and the Department of Education (Division of Bacor City) for the perpetual use of the said parcels of land by the DepEd in a usufructuary capacity.

**RESOLVED LASTLY**, to furnish the Sangguniang Panlalawigan of Cavite, the Office of the Provincial Governor, and other government offices concerned shall be furnished with copies of this Resolution.

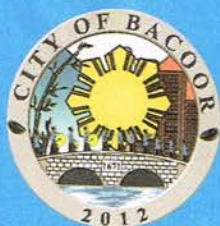
