**WHEREAS**, the Sangguniang Panlungsod has received numerous complaints coming from the urban poor sector of the City of Bacoor in relation to the failure of the Bacoor Urban Poor Development Council particularly its Executive Director, Ms. Esperanza Alferez, to act expeditiously on various single-metering applications;

**WHEREAS**, the single-metering program was launched by the City Mayor, Hon. Strike B. Revilla, in order to assist informal settlers to legally obtain electric services from the Manila Electric Company. In order to ensure the orderly implementation of the said program, the City Mayor assigned the task of facilitating single-metering applications to the Bacoor Urban Poor Development Council;

**WHEREAS**, despite the best intentions of the city government, inordinate delays have been experienced by many informal settlers who have applied for inclusion under the said program;

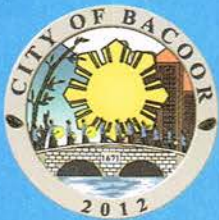
