**A RESOLUTION FORMALLY ORGANIZING THE COMPOSITION OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF THE CITY OF BACOR, CAVITE.**

**WHEREAS**, Section 3, Rule 11 of Memorandum Circular No. 2007-001 entitled the "Uniform Rules of Procedure Before the Administrative Disciplinary Authorities and the Internal Affairs Service of the Philippine National Police" issued on March 6, 2007 provides that the composition of each PLEB shall be as follows:

- a) A member of the Sangguniang Bayan/Panglungsod concerned chosen by his/her respective Sanggunian
- b) A punong-barangay of the city/municipality concerned chosen by the Liga ng mga Barangay
- c) Three (3) other members, who can be removed only for cause, chosen by the city/municipal peace and order council from among the respected members of the community known for their probity and integrity, one (1) of whom must be a woman and another, a member of the Bar, or in the absence thereof, a college graduate, or, the principal of the central elementary school in the locality.

**NOW, THEREFORE**, upon motion of Councilor Venus D. De Castro duly seconded by all the members present in regular session assembled **BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod of Bacoor, to formally organize the People's Law Enforcement Board (PLEB) of the City of Bacoor, Cavite to be composed of the following members:

- 1) **Councilor Hernando C. Gutierrez** representing the Sangguniang Panlungsod of Bacoor;
- 2) **Punong Barangay Victorio L. Guerrero, Jr.** of Brgy. Salinas II, City of Bacoor, Cavite representing the Liga ng mga Barangay of Bacoor, Cavite
- 3) **Mr. Benjamin Leaño;**
- 4) **Atty. Arnel Espiritu;** and
- 5) **Mrs. Teresita Lopez.**

**RESOLVED FURTHER**, that copies of this Resolution be furnished to the Chairman of the National Police Commission, Makati, Metro Manila; the Provincial Director, Camp. Gen. Pantaleon Garcia, Imus, Cavite; the Provincial Governor, Trece Martires City; PNP Station Commander, City of Bacoor, Cavite and the City Mayor for their information and guidance.

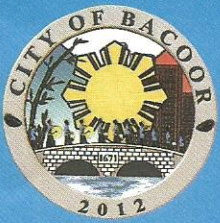
