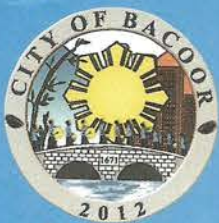
A RESOLUTION RESPECTFULLY APPEALING TO THE MAYNILAD WATER SERVICES INC. TO EXPEDITE THE CONSTRUCTION OF A CENTRALIZED SEWAGE TREATMENT FACILITY WITHIN THE CITY OF BACCOOR PURSUANT TO THE EN BANC RESOLUTION ISSUED BY THE HONORABLE SUPREME COURT IN G.R. Nos. 171947-48 ENTITLED "MMDA vs. CONCERNED MANILA BAY RESIDENTS" PROMULGATED ON 15 FEBRUARY 2011.

WHEREAS, in the landmark case of *MMDA vs. Concerned Manila Bay Residents*, the Honorable Supreme Court ordered various government agencies including the Metropolitan Waterworks and Sewerage System (MWSS) and its concessionaires such as the Maynilad Water Services Inc. (Maynilad) to "provide, install, operate, and maintain the necessary adequate waste water treatment facilities in Metro Manila, Rizal, and Cavite where needed at the earliest possible time."

WHEREAS, the said landmark decision was promulgated on 11 February 2011 but until now, the Maynilad has yet to install,

De Leon, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session assembled to respectfully appeal to the Maynilad to expedite the construction and operation of a waste water treatment facility within the City of Bacoor in compliance with the En Banc Resolution promulgated by the Honorable Supreme Court in "MMDA vs. Concerned Manila Bay Residents".

RESOLVED MOREOVER, this Resolution shall take effect immediately after it has been published once in a local newspaper of general circulation and after it has been posted on the bulleting board at the entrance of the city hall and in two other conspicuous places within the City of Bacoor.

RESOLVED LASTLY, to furnish the Maynilad, the Department of Environment and Natural Resources, the City Environment and Natural Resources Office, the City Interior and Local Government Operations Officer, and other government offices concerned with copies of this Resolution.
