A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF UNDERSTANDING WITH THE PHILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATIONS (POEA), THE OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA), THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), AND THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR ON ANTI-ILLEGAL RECRUITMENT AND TRAFFICKING IN PERSONS.

- 2) establishment of OFW desks or kiosk;
- 3) remedial programs in support of AIR-TIP campaign; and
- 4) data collection and management on OFWs for local policy formulation and plan development.

WHEREAS, a draft copy of Memorandum of Understanding was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for its review and consideration.

WHEREAS, the above mentioned subject was deliberated upon by the council and was found to be beneficial to the public.

NOW THEREFORE, upon motion of Hon. Leandro A. De Leon unanimously seconded by all the councilors present in regular session **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Understanding with the Philippine Overseas Employment Administrations (POEA), the Overseas Workers Welfare Administration (OWWA), the Department Of Labor And Employment (DOLE), and the Technical Education and Skills Development Corporation (TESDA) for and on behalf of the City Government of Bacoor on anti-illegal recruitment and trafficking in persons.

RESOLVED LASTLY, to furnish the POEA, the OWWA, the DOLE, the TESDA, and all government offices concerned with copies of this resolution.
