(DOST) revealed that prevalence of under and over nutrition still persists among Filipino children and has significantly increased as compared to the last survey ;

WHEREAS, the 2006 Family income and Expenditure Surveys (FIES) conducted by the National Statistics Office every three years revealed that about 11 percent of Filipino families had incomes that cannot buy the food needed by family members for nutritional well-being and health. These families could be considered as hungry and food-poor;

WHEREAS, the Department of Social Welfare and Development (DSWD), in its mandate to provide social welfare and development programs particularly through technical assistance and resource augmentation, is providing nutrition services to its clients at the local level through the center-based and community-based services in partnership with Non-Government Organizations under Protective Services Bureau, such as the Food for School and Healthy Start Feeding Program in day care centers which were previously implemented nutrition programs of the Department;

WHEREAS, the President's State of the Nation Address (SONA) in July 26, 2010, emphasized that the thrust of his Administration is to strengthen and maximize Public-Private Partnership along implementation of various programs and projects. As an initial response, a meeting was held on August 9, 2010, regarding the opportunities for partnership between DSWD and private sector partners on supplemental feeding;

WHEREAS, though malnutrition among children is a problem that needs to be addressed by the government, children who are at risk of malnutrition should also be given equal consideration to prevent them from becoming malnourished;

NOW, THEREFORE, for and in consideration upon motion of all the Councilors present, in regular session assembled, be it resolved as it is hereby resolved to ratify the Memorandum of Agreement (MOA) signed and entered into and by between the local government of the City of Bacoor with the Department of Social Welfare Development regarding the Supplementary Feeding Program to be implemented within the city of Bacoor.

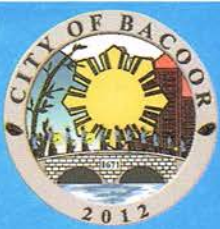
