Palabrica, unanimously seconded by the members of the Sangguniang Panlungsod in regular session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to name the soon to be completed gymnasium at the Bacoor City Government Center as the "**Bacoor City S.T.R.I.K.E. (Sports Training Incorporating Kinesics Education) Gymnasium**".
