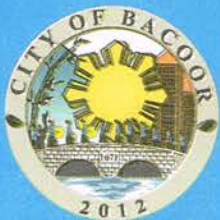
CITY RESOLUTION NO. 2014-131

A RESOLUTION AMENDING RULE 9.2. TO 9.3 OF THE SANGGUNIANG PANLUNGSOD RECORDS AND ARCHIVING MANAGEMENT MANUAL REGARDING THE CONTROL NUMBERING SYSTEM OF THE SANGGUNIANG PANLUNGSOD.

WHEREAS, Rule 9.2 of the Sangguniang Panlungsod Records and Archiving Management Manual (the "Manual") provides that: "Resolutions and ordinances approved on 7 January 2013 shall be numbered using the year when it was passed followed by a dash and then by the number "1", and so forth, shall be used (sic). Thus, the first resolution to be approved by the SP for 2013 shall be known as "**City Resolution No. 2013-1**" while the first ordinance to be enacted shall be known as "**City Ordinance No. 2013-1**".

WHEREAS, Rule 9.3. of the Manual further provides that:
 "The numbering of approved ordinances and resolutions shall be continuing and only the year of approval will be changed. Thus, if the SP approved 54 ordinances/resolutions in 2013, the first ordinance/resolution to be enacted in 2014 shall be known as **"City Ordinance No. 2014-55"** or **"City Resolution No. 2014-55"**."

WHEREAS, the wording of Rule 9.2. and 9.3 has resulted in confusion considering that a situation might arise where a resolution and an ordinance passed on the same year would have the same control number.

NOW THEREFORE, upon motion of Councilor Venus D. De Castro, unanimously seconded by the members of the Sangguniang Panlungsod in regular session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to amend Rule 9.2 and Rule 9.3 of the Sangguniang Panlungsod Records and Archiving Management Manual so that they shall henceforth read as follows:

"Rule 9.2: Numbering of Approved Resolutions/ Ordinances. Resolutions approved beginning on 2 June 2014 shall be numbered using the following format: **City Resolution No. CR 2014-1** with the letters "CR" signifying the words "city resolution"; the numbers "2014" signifying the year when the said resolution was passed while the number "1" shall signify that it is the first resolution passed by the SP following the approval of City Resolution No. 2014-131 on 26 May 2014.

Ordinances approved beginning on 2 June 2014 shall be numbered using the following format: **City Ordinance No. CO 1-2014** with the letters "CO" signifying the words "city ordinance"; the number "1" signifies that the measure was the first ordinance passed following the approval of City Resolution No. 2014-131 on 26 May 2014; while the numbers "2014" signifies the year when the ordinance was passed."

"Rule 9.3: Continuous Numbering System. The numbering of approved ordinances and resolutions shall be continuing and only the year of approval will be changed. Thus, if the SP approved 54 ordinances/resolutions in 2014, the first ordinance/resolution to be enacted in 2015 shall be known as **"City Ordinance No. CO 1-2015"** or **"City Resolution No. CR 2015-1"**."

RESOLVED FURTHER, that copies of this Resolution be sent to all other government offices concerned.

RESOLVED LASTLY, that this Resolution shall become effective after it has been posted in at least three conspicuous places within the City of Bacoor and after it has been published
