A RESOLUTION RATIFYING THE DEED OF DONATION SIGNED BY THE CITY MAYOR, ON BEHALF OF THE CITY GOVERNMENT OF BACOR AND BY THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REGARDING THE DONATION OF A TRASH BOAT TO ENFORCE AND IMPLEMENT THE OPERATIONAL PLAN FOR THE MANILA BAY COASTAL STRATEGY (OPMBCS).

WHEREAS, the Department of Environment and Natural Resources (DENR) procured a Trash Boat to enforce and implement the Operational Plan for the Manila Bay Coastal Strategy (OPMBCS) in compliance with the February 15, 2011 Resolution of the Supreme Court pursuant to the Continuing Mandamus issued through its December 18, 2008 Decision in G.R. Nos. 171947-48;

WHEREAS, the DENR recognizes the contributory effort of the City Government of Bacoor in effective Solid Waste Management along Manila Bay;

WHEREAS, the DENR intends to donate the said Trash Boat No. 9 unto the City Government of Bacoor;

WHEREAS, the Sangguniang Panlungsod reviewed the said Deed of Donation and unanimously decided to ratify the same.

NOW THEREFORE, upon motion of Hon. Edwin G. Gawaran unanimously seconded by all the councilors present in regular session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to ratify the Deed of Donation signed by the City Mayor, on behalf of the City Government of Bacoor and by the Department of Environment and Natural Resources (DENR) regarding the donation of a trash boat purposely to enforce and implement the Operational Plan for the Manila Bay Coastal Strategy (OPMBCS).
