**A RESOLUTION OPPOSING THE APPLICATION OF PRIMEWATER INFRASTRUCTURE CORPORATION OPERATOR OF THE WATERWORKS SYSTEM AT SPRINGVILLE NORTH SUBDIVISION, BARANGAY MOLINO, BACOR, CAVITE, FOR THE RENEWAL OF ITS CERTIFICATE OF PUBLIC CONVENIENCE.**

**WHEREAS**, data submitted to the Sangguniang Panlungsod by the Provincial Environment and Natural Resources Office (PENRO) show that the groundwater supply of the City of Bacoor is now at a perilous level;

**WHEREAS**, reports have reached the Sangguniang Panlungsod that privately-owned artesian wells in barangays located near the coastal areas of the city are now drawing saltwater due to the diminution of the City's groundwater supply;

**WHEREAS**, the continuous drawing of water from the City's aquifer prevents the replenishment of the latter through natural hydrologic activities;

**WHEREAS**, the Maynilad Water Services Inc. is now installing water pipelines all over the City. Soon, the people of the City of Bacoor shall have access to safe and potable water supply courtesy of Maynilad. Consequently, the Sangguniang Panlungsod opposes all applications for the renewal of certificates of public convenience such as that filed by Primewater Infrastructure Corporation operator of the waterworks system at Springville North Subdivision, Barangay Molino, Bacoor, Cavite due to the detrimental effects of the unabated drawing of water from the City's aquifer to the environment.

**NOW THEREFORE**, upon motion of Hon. Reynaldo M. Fabian, unanimously seconded by all the members present, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to oppose all applications for the renewal of certificates of public convenience such as that filed by Primewater Infrastructure Corporation, operator of the waterworks system at Springville North Subdivision, Barangay Molino, Bacoor, Cavite due to the detrimental effects of the unabated drawing of water from the City's aquifer to the environment.
