A RESOLUTION AUTHORIZING THE EXTENSION OF THE GARBAGE HAULING CONTRACT OF THE CITY GOVERNMENT OF BACOR, CAVITE WITH FRTECH-AJR 528 WASTE DISPOSAL INC. AND S.B. HAIN ENTERPRISES AND GENERAL SERVICES SUBJECT TO CERTAIN CONDITIONS.

WHEREAS, the Sangguniang Panlungsod was informed by the City Mayor that the contract of FRTECH-AJR 528 Waste Disposal Inc. and S.B. Hain Enterprises and General Services with the City of Bacoor for the hauling of the city's garbage expired on 31 December 2014;

WHEREAS, the City Mayor requested the Sangguniang Panlungsod to pass a resolution authorizing the extension of the said contract until 31 January 2015;

WHEREAS, the Sangguniang Panlungsod has neither reviewed nor approved the terms and conditions of the said contract but has agreed to deliberate on the request of the City Mayor in view of its urgent nature and the public health risks that might arise in case the said contractor stops collecting the city's garbage after 31 December 2014;

WHEREAS, after careful deliberation of the issues involved, the Sangguniang Panlungsod has agreed to grant the City Mayor's request subject to certain terms and conditions:

NOW THEREFORE, be it **RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session assembled that:

Section 1. The City Mayor is hereby granted the authority to negotiate with FRTECH-AJR 528 Waste Disposal Inc. and S.B. Hain Enterprises and General Services for the purpose of extending the same until 31 January 2015 provided that the terms and conditions of such contract extension should be in accordance with law and ordinance and should not be disadvantageous to the government. Provided further that such extension shall not go beyond 31 January 2015.

Section 2. The provisions of any contract involving the hauling, handling, or disposal of the city's solid waste shall be subject to the review and approval of the Sangguniang Panlungsod before the same can be signed by the City Mayor or implemented by the City Government in view of its obvious impact on the health of the city's inhabitants and of the environment.

If any provision of this Resolution is declared void or unenforceable by the proper court of law, the said judicial declaration shall automatically prohibit the City Mayor from implementing the provisions of any contract or agreement covered by this Resolution.
