A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRADE AND INDUSTRY-CAVITE PROVINCIAL OFFICE FOR AND ON BEHALF OF THE CITY OF BACOR, CAVITE WITH REGARD THE IMPLEMENTATION OF THE "TIMBANGAN NG BAYAN PROJECT".

WHEREAS, protecting consumer rights is the hornbook principle behind Republic Act No. 7394 (the Consumer Act of the Philippines).

WHEREAS, pursuant to Article 61 of the Consumer Act, the Department of Trade and Industry (DTI) has been mandated by law to protect and promote the rights of consumers in cooperation with the city or municipal treasurers by implementing measures intended to prevent the use of tampered weighing scales in public markets and other commercial establishments.

WHEREAS, one of the programs of the DTI intended to promote the rights of consumers is the "Timbangan ng Bayan Project" which would entail the installation of four (4) tamper-proof weighing scales in various public markets within the City of Bacoor.

WHEREAS, the Office of the City Mayor submitted a draft Memorandum of Agreement between the City of Bacoor and the DTI regarding the afore-mentioned project for the review and consideration of the Sangguniang Panlungsod.

WHEREAS, the Sangguniang Panlungsod reviewed the various terms and conditions of the said agreement and found the same to be in accordance with law and beneficial to the interests of the people of the City of Bacoor.

NOW THEREFORE, upon motion of Hon. Gaudencio Nolasco, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session duly assembled to authorize the City Mayor, Hon. Strike B. Revilla, to sign the Memorandum of Agreement mentioned above for and on behalf of the City of Bacoor regarding the implementation of the DTI's "Timbangan ng Bayan Project".
