**A RESOLUTION REQUESTING HIS EXCELLENCY, PRESIDENT BENIGNO SIMEON C. AQUINO III, TO DECLARE JUNE 23, 2015 AND SEPTEMBER 29, 2015 AS SPECIAL NON-WORKING HOLIDAYS IN THE CITY OF BACOR, CAVITE TO COMMEMORATE THE CREATION OF THE COMPONENT CITY OF BACOR ON JUNE 23, 2012 AND THE FOUNDING OF THE TOWN OF BACOR ON SEPTEMBER 29, 1671.**

**WHEREAS**, the Spaniards established the town of Bacoor on September 29, 1671.

**WHEREAS**, the component City of Bacoor, Cavite was created by law pursuant to the ratification of Republic Act No. 10160 by the people of Bacoor in a plebiscite.

**WHEREAS**, the local government of the City of Bacoor celebrates the founding of the historic town of Bacoor during its town fiesta held on September 29 of every year. On the other hand, the creation of the component City of Bacoor is commemorated every June 23.

**WHEREAS**, declaring June 23, 2015 and September 29, 2015 as special non-working holidays would enable the people of the City of Bacoor especially the youth to better understand and appreciate the significance of the said dates.

**NOW THEREFORE**, upon motion of Hon. Rowena Bautista-Mendiola, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session duly assembled to respectfully request His Excellency, President Benigno Simeon C. Aquino III, to declare June 23, 2015 and September 29, 2015 as special non-working holidays in the City of Bacoor, Cavite to commemorate the creation of the component City of Bacoor, Cavite on June 23, 2012 and the founding of the historic town of Bacoor on September 29, 1671.
