**A RESOLUTION AUTHORIZING THE CITY MAYOR TO RENEW THE LICENSING AGREEMENT BETWEEN THE INTEL COMPUTER CLUBHOUSE NETWORK AND THE CITY GOVERNMENT OF BACOR FOR THE BENEFIT OF THE BACOR COMPUTER CLUBHOUSE.**

**WHEREAS**, the then Municipal Government of Bacoor established the Bacoor Computer Clubhouse for the benefit of children without access to computers or the internet.

**WHEREAS**, to equip the Bacoor Computer Clubhouse access to high-tech learning computer software and technical training designed by the Massachusetts Institute of Technology (MIT) and the Museum of Science in Boston, Massachusetts, USA, the city government entered into a licensing agreement with the Intel Computer Clubhouse Network.

**WHEREAS**, there is now a need to renew the said agreement in view of its expiration.

**NOW, THEREFORE**, upon motion of Hon. Miguel N. Bautista duly seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to grant a continuing authority to the City Mayor to sign the Licensing Agreement between the City Government of Bacoor and the Intel Computer Clubhouse Network provided that the terms and conditions thereof are similar to those found in the existing agreement and that the said contractual provisions are not contrary to law.

**RESOLVED LASTLY**, to furnish all government offices and agencies concerned with copies of this Resolution.
