WHEREAS, under Proclamation No. 682, President Corazon Aquino declared February of every year as Civil Registration Month. February 23 was also declared as National Birth Registration Day starting in 2005.

WHEREAS, in line with this year's celebration of the Civil Registration Month, the Philippine Statistics Authority (PSA) Cavite in coordination with the Cavite Association of Civil Registrars to have different activities starting February 10 to February 27, 2015 for the benefit of the public.

WHEREAS, the Office of the Civil Registrar of the City of Bacoor proposed the launching of the "On Site Birth Registration" program from February 10-27, 2015 in celebration of the Civil Registration Month.

WHEREAS, the Office of the City Civil Registrar requested the Sangguniang Panlungsod to authorize its office to accept the birth registration of indigent residents of the City of Bacoor for free every Saturday inside residential subdivisions within the City of Bacoor.

NOW, THEREFORE, upon joint motion of Hon. Reynaldo M. Fabian and Hon. Hernando C. Gutierrez duly seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Civil Registrar's Office to accept the birth registration of indigent residents of the City of Bacoor for free which known as "On Site Birth Registration".
