**WHEREAS**, the Bacoor City Health Office is in need of a DOH accredited laboratory who can monitor the quality of water of all water suppliers and water refilling stations in the city in a very affordable price.

**WHEREAS**, the Department of Science and Technology, Region IV-A is a government facility with a DOH accredited/certified laboratory capable of monitoring the bacteriological, physical, chemical, biological and radiological quality of water.

**WHEREAS**, a draft copy of the Memorandum of Agreement was sent by the Office of the City Mayor to the Sangguniang Panlungsod for its review and consideration;

**NOW, THEREFORE**, upon motion of Hon. Reynaldo M. Fabian duly seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor to sign and enter into a Memorandum of Agreement between the Bacoor City Health Office and the Department of Science and Technology, Region IV-A.
