WHEREAS, the Sangguniang Panlungsod received a copy of a letter from the Astroville Homeowners Association dated 9 February 2015 addressed to the City Mayor, Hon. Strike B. Revilla, formally turning over Astroville Subdivision located at Brgy. Queensrow West, Bacoor City, Cavite to the city government.

WHEREAS, according to Mr. Alex Caraveo, President of the said homeowners association, the said subdivision has been abandoned by its developer and no additional improvements have been done thereon for the past 25 years.

WHEREAS, Mr. Caraveo also disclosed to the Sangguniang Panlungsod that the homeowners of the said subdivision decided to turnover the various road lots and open spaces of Astroville Subdivision to the city government during its recent general assembly so that the city government may construct a multi-purpose hall on Lot 12, Block 11 inside the said residential subdivision where its water tank is presently located.

WHEREAS, the city government does not presently have enough funds to finance the construction of the said multi-purpose hall.

WHEREAS, the Sangguniang Panlungsod unanimously decided to accept the formal turnover to the City of Bacoor of the various road lots and open spaces of Astroville Subdivision located at Brgy. Queensrow West, Bacoor City, Cavite and to respectfully request Rep. Lani Mercado-Revilla of the 2nd legislative district of the Province of Cavite to provide the necessary funds to construct a multi-purpose hall on Lot 12,
