REVILLA TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH COCA-COLA FAR EAST, LIMITED AND THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) REGARDING THE IMPLEMENTATION OF ITS "SARI-SARI STORE TRAINING AND ACCESS TO RESOURCES" (STAR) PROGRAM ON BEHALF OF THE CITY GOVERNMENT OF BACOR, CAVITE.
