**A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT- REGION IV-A FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR.**

**WHEREAS**, the infrastructure development program of the national government as reflected in the Philippine Development Plan (PDP) for 2011-2016 aims to contribute to high-impact flood control projects, climate change adaptation and disaster risk reduction, through the construction of safe, efficient, cost-effective and sustainable infrastructure;

**WHEREAS**, Executive Order No. 43, Series Of 2011 mandated the implementation of **Bottom-Up Budgeting (BUB)** program to ensure the inclusion of the funding requirements for the development needs of focus cities and municipalities in the budget proposals of the participating national agencies;

**WHEREAS**, Chapter XIV.A.3.7, Provision for Grassroots Participatory Budgeting Program under Republic Act 10651 (FY 2015 General Appropriations Act) provided the allocation for 2015 BUB projects;

**WHEREAS**, Joint Memorandum Circular No. 4 Series of 2013, among the Department of Budget and Management (DBM), the Department of Interior and Local Government (DILG), the Department of Social Welfare and Development (DSWD) and National Anti-Poverty Council (NAPC) provides policy guidelines and procedures in the implementation of BUB;

**WHEREAS**, the City of Bacoor, Cavite has been identified by the DBM, DILG, DSWD, and the NAPC as one of the local government units being considered as BUB areas.

**WHEREAS**, the proposed project of the City of Cavite in the BUB program is the implementation of a flood control project in Brgy. Molino 7, Bacoor City, Cavite.

**WHEREAS**, a draft Memorandum of Agreement between the DILG-National Capital Region and the City of Bacoor regarding the implementation of the said flood control project under the BUB was submitted by the Office of the City Mayor for the review and consideration of the Sangguniang Panlungsod.
