WHEREAS, Addas Development Corporation is the registered owner of a parcel of land covered by Transfer Certificate of Title No. T-616727 located at San Nicolas, City of Bacoor, Cavite containing an area of Twenty Nine Thousand Thirty Nine (29,039) square meters.

WHEREAS, the city government constructed the San Nicolas Elementary School Buildings on the Five Thousand (5,000) square meters which is a portion of the lot covered by the abovementioned TCT No. 616727 to be donated by Addas Development Corporation;

WHEREAS, a draft copy of Deed of Donation was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration.

NOW, THEREFORE, after careful deliberation, on motion of Councilor Edwin G. Gawaran unanimously seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Strike B. Revilla, to sign a Deed of Donation with Addas Development Corporation regarding the donation of a parcel of land situated at San Nicolas, City of Bacoor, Cavite for and on behalf of the City Government of Bacoor.
