A RESOLUTION RATIFYING THE " SECOND AMENDMENT TO TERM LOAN AGREEMENT" DATED 25 FEBRUARY 2015 BETWEEN THE CITY OF BACOR AND THE DEVELOPMENT BANK OF THE PHILIPPINES.

WHEREAS, on 25 February 2015, the City Mayor, Hon. Strike B. Revilla, signed a " *Second Amendment to Term Loan Agreement*" with the DBP (represented by its DBP-Dasmariñas Branch Head, Mr. Romel P. San Diego). The said instrument extended to the commitment period to 30 June 2015.

WHEREAS, a copy of the said *Second Amendment to Term Loan Agreement* was submitted by the City Mayor for ratification by the Sangguniang Panlungsod.

WHEREAS, after a thorough review of the terms and conditions of the said *Second Amendment to Term Loan Agreement*, the Sangguniang Panlungsod unanimously decided to ratify the said instrument.

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica unanimously seconded by all the councilors present in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to ratify the *Second Amendment to Loan Term Agreement* dated 25 February 2015 between the City of Bacoor and the Development Bank of the Philippines.

RESOLVED FURTHER, to furnish the DBP and all other government agencies concerned with copies of this Resolution.

RESOLVED LASTLY, this Resolution shall take effect upon its posting in three conspicuous places within the City of Bacoor and its publication at least once in a newspaper of general circulation within the Province of Cavite.
