WHEREAS, Phase I, Homeowner's Association, Perpetual Village 7, Bacoor City, Cavite is the recipient of a real property from BP International Development Corporation, the developer of Perpetual Village Subdivision, consisting an aggregate area of Two Thousand Four Hundred Fifty Two (2,452) square meters, located at Begonia corner Daffodil St., Perpetual Village 7, Bacoor City, Cavite.

WHEREAS, the said homeowner's association donated a portion of the above-mentioned lot consisting of One Thousand (1,000) square meters to the City Government of Bacoor for the construction by the latter of an evacuation center for the use of its residents and for other government purposes;

WHEREAS, a signed copy of a Deed of Donation covering the said property was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for ratification;

NOW, THEREFORE, after careful deliberation, on motion of Councilor Edwin G.
