A RESOLUTION APPROVING THE FIVE (5) YEAR PLAN OF THE BACOR DISASTER RISK REDUCTION AND MANAGEMENT OFFICE ON THE UTILIZATION OF THE UNEXPENDED BALANCE OF THE 2014 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND AMOUNTING TO FOURTEEN MILLION ONE HUNDRED SIXTY THREE THOUSAND FIVE HUNDRED EIGHTEEN PESOS AND TWENTY ONE CENTAVOS (PHP14,163,518.21).

WHEREAS, on 11 March 2015, the Bacoor Risk Reduction Management Council (BDRRMC) passed Resolution No. 01, Series of 2015 entitled, " A Resolution Adopting The Five (5) Year Plan Of The Bacoor Disaster Risk Reduction And Management Office On The Utilization Of The Unexpended Balance Of The 2014 Local Disaster Risk Reduction And Management Fund".

WHEREAS, a copy of the said resolution was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for its review and consideration.

WHEREAS, the unexpended balance of the LDRRMF is (PhP14,163,518.21) that covers the construction of retaining walls, drainages and other infrastructures at various locations, desilting, clearing and rehabilitation of rivers, drainages and other waterways.; construction of evacuation centers and facilities; and improvement and rehabilitation of roads and bridges.

NOW THEREFORE, in view of the foregoing, on motion of Hon. Bayani M. De Leon unanimously seconded by all the councilors present in regular session **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to approve the five (5) year plan of the Bacoor Disaster Risk Reduction and Management Office on the utilization of the unexpended balance of the 2014 Local Disaster Risk Reduction and Management Fund amounting to Fourteen Million One Hundred Sixty Three Thousand Five Hundred Eighteen Pesos and Twenty One Centavos (PhP14,163,518.21).
