**A RESOLUTION COMMENDING THE POLICE OFFICERS ASSIGNED AT THE BACOR PNP FOR THEIR EXEMPLARY PERFORMANCE OF THEIR DUTY RESULTING IN THE KILLING OF FOUR (4) MEMBERS OF THE DREADED GAPOS GANG IN THE MORNING OF 6 MAY 2015 AT BARANGAY MOLINO 7, BACOR CITY, CAVITE.**

**WHEREAS**, a robbery took place at Allure Spa in Barangay Panapaan 4 at around 10:00 pm on 5 May 2015. Four (4) armed men posed as customers of the said establishment and hogtied six employees of the spa as well as one customer. They also stole the money earned by the spa that day amounting to P20,000 more or less as well as the personal belongings of the victims. The armed men also stole a grey Toyota Innova owned by the customer who was hogtied inside the spa. Before leaving, some of the armed robbers also sexually molested some of the female victims. After the robbers left, one of the victims managed to report the robbery to the Bacoor PNP.

**WHEREAS**, upon receipt of the said report, P/Supt. Rommel Estolano swiftly ordered the setting up of checkpoints in strategic locations within the City of Bacoor. The armed robbers, using the stolen vehicle mentioned above, evaded the checkpoint along Molino Boulevard in Barangay Bayanan prompting elements of the Bacoor PNP to pursue the said vehicle.

**WHEREAS**, the suspects were finally cornered on the Gawaran Bypass Road in Barangay Molino VII but instead of capitulating, the malefactors fired at the police authorities forcing the latter to return fire. When the gun smoke settled, all of the suspects were killed and everything they stole was successfully recovered.

**WHEREAS**, the Sangguniang Panlungsod believes that the prompt and decisive action of the Bacoor PNP as narrated above is worthy of commendation.

**NOW THEREFORE**, upon joint and unanimous motion of all its members present **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session duly assembled to commend the police officers of the Bacoor
