**A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE POPULATION COMMISSION (POPCOM) – REGION IV AND THE BACOR NATIONAL HIGH SCHOOL (BNHS) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR, CAVITE.**

**WHEREAS,** POPCOM is the government agency mandated to be the over-all coordinating body for the Philippine Population Management Program (PPMP), a nationwide government program that is being implemented by various national and regional line agencies, local government units, non-government organizations and people's organizations;

**WHEREAS,** one of the major program thrusts of the PPMP is to ensure that young people/adolescents are provided with appropriate information, knowledge, education and services on population, development and reproductive health;

**WHEREAS,** in promoting the program thrusts for young/adolescents, POPCOM through its regional offices is partnering and collaborating with various stakeholders to pilot, implement, coordinate, and establish relevant programs addressing adolescents issues and concerns;

**WHEREAS, POPCOM REGION IV** entered into a tri-partnership agreement and collaboration with the **City of Bacoor** and the **BNHS**, to undertake the sustainability of the school-based teen center, named "**IsCool Teen Center**" (ITC);

**WHEREAS,** the City of Bacoor, through its **City Mayor Hon. Strike B. Revilla**, has identified and initiated the establishment of a **school-based teen center** IN BNHS;

**WHEREAS,** the BNHS agreed to manage and operate the said school-based teen center by the concerned teachers and selected students of the school;

**WHEREAS,** the City of Bacoor and BNHS as pilot LGU and institution respectively, will benefit from the project by enabling the growing youth population, particularly the students of BNHS, towards improved and responsible behavior and therefore shaping these young people to become productive members of society;
