A RESOLUTION SUPPORTING AND ENDORSING THE REQUEST OF CITY PROSECUTOR JOHNNY UMPONG TO CONVERT THE THIRD FLOOR OF THE EXISTING CITY HALL FOR THE USE OF THE CITY PROSECUTORS' OFFICE AND THE PUBLIC ATTORNEYS' OFFICE.

WHEREAS, City Prosecutor Johnny Umpong requested the City Mayor, Hon. Strike B. Revilla, in writing for authority to convert the third floor of the existing City Hall of the City of Bacoor, Cavite for use by the City Prosecutors' Office. The City Mayor forwarded the said request to the Sangguniang Panlungsod for appropriate action.

WHEREAS, the Sangguniang Panlungsod have already previously approved the conversion of the ground and second floor of the existing City Hall for use by the Regional Trial Court and Metropolitan Trial Court of the City of Bacoor once the Bacoor City Government Center in Barangay Bayanan is completed within the current year.

WHEREAS, while there is obvious merit in the request of the City Prosecutor for the third floor of the existing City Hall to be converted for use by the City Prosecutors Office, the Sangguniang Panlungsod believes that the third floor of the existing City Hall is spacious enough to also accommodate the Public Attorneys Office of the City. The council also believes that placing the City Prosecutors Office and the Public Attorneys Office on the same office level shall be boon to the public and shall improve the administration of justice.

NOW THEREFORE, upon joint and unanimous motion of all its members present **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session duly assembled to approve and endorse the request of City Prosecutor Johnny Umpong to convert the third floor of the existing City Hall for use by the City Prosecutors Office.

RESOLVED FURTHER that the Public Attorneys Office shall likewise use the third floor of the existing City Hall.

RESOLVED MOREOVER that the conversion of the said third level of the existing City Hall shall commence alongside the renovation of the first and second floor of the said
