A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A COMPROMISE AGREEMENT BETWEEN NC TAVU AND ASSOCIATES INC. AND THE CITY OF BACOR IN THE UNLAWFUL DETAINER CASE BETWEEN THE CITY OF BACOR AND NC TAVU AND ASSOCIATES INC. DOCKETED AS CIVIL CASE NO. 13-3923 PENDING BEFORE THE MUNICIPAL TRIAL COURT OF THE CITY OF BACOR, CAVITE.

WHEREAS, the City of Bacoor (represented by its Mayor, Hon. Strike B. Revilla), filed an unlawful detainer case against defendant N.C. TAVU AND ASSOCIATES CORP. (represented by its Pres. ARCH NEIL C. TAVU, HENDRIX M. DEL ROSARIO SPS. HERNANDO M. DEL ROSARIO And FLAVIANA M. DEL ROSARIO) docketed as Civil Case No. 13-3923 before the Municipal Trial Court of the City of Bacoor involving the unlawful possession of the Bacoor Public Market by the spouses Hernando M. Del Rosario and Flaviana M. Del Rosario.

WHEREAS, the City of Bacoor and NC Tavu and Associates Inc. agreed to amicably settle their differences in the said case and enter into a Compromise Agreement. A copy of the said Compromise Agreement was submitted by the City Mayor for the review and consideration of the Sangguniang Panlungsod.

WHEREAS, the Sangguniang Panlungsod deliberated upon the proposed Compromise Agreement and found the contents thereof advantageous to the City of Bacoor and not contrary to law.

NOW THEREFORE, upon unanimous motion of all its members present, **BE IT RESOLVED AS IT IS HERBY RESOLVED** by the Sangguniang Panlungsod in regular session duly assembled to authorize the City Mayor, Hon. Strike B. Revilla, to sign the proposed Compromise Agreement between NC Tavu and Associates Inc. and the City of Bacoor in the unlawful detainer case docketed as Civil Case No. 13-3923 now pending before the Municipal Trial Court of the City of Bacoor.

RESOLVED LASTLY, to submit this Resolution for the consideration and approval of the Sangguniang Panlungsod of the City of Bacoor, Cavite.
