A RESOLUTION ENDORSING THE BACOR RING OF LIFE PROJECT AS PART OF COMPREHENSIVE DEVELOPMENT PROGRAM OF THE CITY OF BACOR, CAVITE AND REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND THE PHILIPPINE ROAD BOARD TO PROVIDE FUNDS FOR ITS CONSTRUCTION IN ORDER TO IMPROVE ROAD SAFETY ALONG MOLINO BOULEVARD IN THE CITY OF BACOR, CAVITE.

WHEREAS, the "Ring of Life Project" is patterned after a similar structure in Japan and the Netherlands with the main purpose of easing traffic congestion as well as pedestrian safety through its hanging walkway, jogging and bicycle paths that will be interconnected with soon to rise commercial malls within the area.

WHEREAS, the said structure will be the first of its kind in the Philippines and shall encourage greater commercial development.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod in regular session duly assembled to approve the resolution endorsing the Bacoor Ring of Life Project as part of the Comprehensive Development Program of the City of Bacoor and requesting the Department of Public Works and Highways (DPWH) and the Philippine Road Board to provide funds for its construction in order to improve road safety along Molino Boulevard in the City of Bacoor, Cavite.
