A RESOLUTION ENDORSING THE REVETMENT CONSTRUCTION PROGRAM ALONG THE BANKS OF THE ZAPOTE RIVER OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS FOR FUNDING OF THE FLOOD MITIGATION PROGRAM OF THE CITY OF BACOR, CAVITE.

WHEREAS, on May 13, 2015, CDC Board Resolution No. 03 Series of 2015 entitled " A resolution endorsing the revetment construction program along the banks of Zapote River of the Department of Public Works and Highways for funding of the flood mitigation program of the City of Bacoor, Cavite" was approved by the Executive Committee of City Development Council during its regular meeting.

WHEREAS, a concrete roadway shall be constructed on top of the said revetment to maximize the public purposes for which the project may be used.

WHEREAS, all of the structures located within 15 meters from the edge of the easement of Zapote River within the jurisdiction of the City of Bacoor shall be affected by the said project.

WHEREAS, the residents of all structures that will be demolished as a consequence of the construction shall be relocated pursuant to the pertinent provisions of Republic Act No. 7279.

WHEREAS, the City Development Council submitted the said project for the consideration of the Sangguniang Panlungsod of the City of Bacoor.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Panlungsod in regular session assembled, to approve the revetment project for the funding of the roadway currently being constructed by the Department of Public Works and Highways (DPWH) along the banks of the Zapote River located in Barangays Aniban 2, Aniban 4, Zapote 3, Zapote 4, Zapote 5, San Nicolas 1, Ligas 1, Ligas 2 and Ligas 3 in support of the flood mitigation program of the City of Bacoor, Cavite.


