A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE- BUREAU OF FISHERIES AND AQUATIC RESOURCES (DA-BFAR) – REGION IV REGARDING THE USE OF A TABLET BY THE CITY AGRICULTURE OFFICE IN RELATION TO THE MUNICIPAL FISHING VESSEL AND GEAR REGISTRATION SYSTEM:

WHEREAS, under Republic Act No. 8550, otherwise known as the "Philippine Fisheries Code of 1998" and the Local Government Code, coastal cities and municipalities have the responsibility to register fishing vessels and fishing gears used by the municipal fisherfolk;

WHEREAS, Bureau of Fisheries and Aquatic Resources is assisting coastal cities and municipalities on fisherfolk registration by including the registration of fishing vessels with three (3) gross tonnage and below and fishing gears under the National Program on Municipal Fishing Vessels and Gear Registration (BoatR);

WHEREAS, Bureau of Fisheries and Aquatic Resources launched BoatR in 2014 to assist cities and municipalities register the municipal fishing vessels and gears subsistent fisherfolk as mandated by the Fisheries Code (R.A. No. 8550);

WHEREAS, to fast track the registration process, BFAR is providing local government units such as the City of Bacoor one (1) unit of tablet device with one (1) – year data subscription to ensure the speedy and consistent submission of report/registration to the BFAR;
