A RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) FOR PROJECTS OUTSIDE THE DPWH REGULAR INFRASTRUCTURE PROGRAM.

WHEREAS, Item No. 89 of the General Provisions of Republic Act No. 10651 otherwise known as the General Appropriations Act of 2015 provides that projects, facilities, programs and services funded the CY 2015 GAA shall be implemented by the appropriate government agency irrespective of the nature and location of such projects, facilities, programs and services, PROVIDED, that the national government may delegate the implementation thereof to local government units with the capability to and which will actually implement the project by themselves, as determined by the Department of Public Works and Highways (DPWH) and through the execution of the Memorandum of Agreement.

WHEREAS, the 2nd paragraph of Item No. 89 of the General Provisions also states that in exceptional cases where the National Government funds the construction of local roads and facilities already developed to the Local Government Units, the National Agency concerned prior to the implementation of the project shall enter into a Memorandum of Agreement with the local government unit recipient requiring the latter to commit to shoulder the cost for the proper maintenance and repair of the said local roads and devolved facilities.

NOW THEREFORE, upon motion of Councilor Reynaldo Palabrica, duly seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor to sign and enter into a Memorandum of Agreement with the Department of Public Works and
