**A RESOLUTION REQUIRING COOPERATIVES BASED OUTSIDE CAVITE PROVINCE THAT INTEND TO ORGANIZE ANY BRANCH IN THE CITY OF BACOOR TO SECURE A CLEARANCE FROM THE SANGGUNIANG PANLUNGSOD OF THE CITY OF BACOOR.**

**WHEREAS**, on 15 June 2015, a letter was sent to the Office of the City Mayor by the Cavite Cooperative Authority (CDA) together with its Council Resolution No. 020-2012 requesting the municipal and city mayors of Cavite to first conduct a public hearing before the issuance of business permits to cooperatives organizing a branch in the province and the Cavite Mayor's League Resolution No. 7 supporting the request of the council by all local chief executives of each municipality /city.

**WHEREAS**, the said letter was endorsed by the Office of the City Mayor to the city council for consideration.

**NOW THEREFORE**, after careful deliberation, upon motion of Councilor Reynaldo D. Palabrica duly seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to require cooperatives based outside Cavite Province that intend to organize any branch in the City of Bacoor to secure a clearance from the Sangguniang Panlungsod.

**RESOLVED FURTHER**, to furnish the CDC, the Office of the City Mayor and all government offices concerned with copies of this resolution.
