LEGASCA, ARTURO SAN DIEGO, AND ANTONIO SAN DIEGO FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR, CAVITE SUBJECT TO COMPLIANCE BY THE DONOR WITH VARIOUS LEGAL REQUIREMENTS.
