A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF BACOR, THROUGH THE CITY MAYOR, HON. STRIKE B. REVILLA, TO PROCURE THREE (3) UNITS OF GALIL ACE 21 N CALIBER 5.56 MM AND FOUR (4) UNITS OF GALIL ACE 23 CALIBER 5.56MM FIREARMS TO BE DONATED AND UTILIZED BY THE BACOR CITY PHILIPPINE NATIONAL POLICE (PNP), SUBJECT TO EXISTING PERTINENT LAWS, RULES, AND REGULATIONS.

WHEREAS, the Bacoor City Philippine National Police aims to provide quality service that will make Bacoor City an ideal community where people live, work and do business in a hospitable, progressive and peaceful environment;

WHEREAS, Mayor Strike B. Revilla lauded the Bacoor PNP for its valuable service to Bacoor City residents and challenged police authorities to work hard to maintain peace and order in the city;

WHEREAS, the Bacoor City PNP is in need of assault rifles in order to enhance its operational capabilities in the enforcement of law and order;

WHEREAS, a draft Deed of Donation was submitted by the Office of the City Mayor for the review and consideration of the City Council of Bacoor involving the donation of **three (3) units of Galil ACE 21 N Caliber 5.56mm and four (4) units of Galil ACE 23 Caliber 5.56mm firearms** by the city government in favor of the Bacoor City PNP.

WHEREAS, the Sangguniang Panlungsod, after a thorough evaluation of the operational capabilities of the Bacoor PNP and the contents of the draft Deed of Donation, hereby authorizes Mayor Strike B. Revilla to procure three (3) units of Galil ACE 21 N Caliber 5.56mm and four (4) units of Galil ACE 23 Caliber 5.56mm firearms and to sign the Deed of Donation, for and in behalf of the City Government of Bacoor, Cavite for the donation of the said firearms to the Bacoor City-Philippine National Police (PNP), subject to existing pertinent laws, rules and regulations.

NOW THEREFORE, upon motion of Hon. Bayani M. De Leon unanimously seconded by all the members present in regular session assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Strike B. Revilla, to procure three (3) units of Galil ACE 21 N Caliber 5.56mm and four (4) units of Galil ACE 23 Caliber 5.56mm and to sign a Deed of Donation, for and in behalf of the City Government of Bacoor, Cavite for the donation of the said firearms to the Bacoor City-Philippine National Police (PNP), subject to existing pertinent laws, rules and regulations.
