A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A DEED OF DONATION BETWEEN ESTHERVILLE PHASE I HOMEOWNERS ASSOCIATION AND THE CITY GOVERNMENT OF BACOR INVOLVING THE DONATION OF PARCEL OF LAND SITUATED AT 5TH ST. SALINAS I, BACOR CITY, CAVITE SUBJECT TO COMPLIANCE BY THE DONOR WITH VARIOUS LEGAL REQUIREMENTS.

WHEREAS, Ma. Corazon Salcedo appears to be the absolute owner of a parcel of land situated at 5th St. Salinas I, City of Bacoor, Cavite covered by Original Certificate of Title No. P-6560 entered pursuant to the Free Patent No. 023088 with an aggregate area of Nine Thousand Eight Hundred Thirty Two (9,832) square meters. A 8,877-square meter portion of the said lot is presently occupied by residents of Estherville Subdivision, Phase I under a Community Mortgage Program (CMP).

WHEREAS, on 20 May 2015, a Deed of Donation was executed between Ma. Corazon Salcedo (deceased) landowner, duly represented by Mrs. Solita Salcedo Marapao as Administratrix and Estherville Phase I Homeowners Association regarding the donation of parcel of land situated at 5th St. Salinas I, Bacoor City, Cavite.

WHEREAS, the donor has given the Estherville Phase I Homeowners Association the authority to offer for site development of the donated road, alleys and open space to the city government for the welfare of its constituents.

WHEREAS, the Office of City Mayor endorsed the copies of documents pertinent to the donated parcels of land to the city council for review and consideration.

NOW, THEREFORE, after careful deliberation, upon motion of Hon. Bayani M. De Leon duly seconded by Hon.
