A RESOLUTION DIRECTING THE CITY PLANNING AND DEVELOPMENT OFFICE TO CAUSE THE ISSUANCE OF A CEASE AND DESIST ORDER AGAINST HOUSEHOLD DEVELOPMENT CORPORATION DUE TO ITS DEVELOPMENT OF THE CAMELLA CARSON RESIDENTIAL SUBDIVISION PROJECT WITHOUT A DEVELOPMENT PERMIT ISSUED BY THE SANGGUNIANG PANLUNGSOD AS MANDATED BY LAW.

WHEREAS, under Article IV, Section 11 (4) of Republic Act No. 10160, (also known as the Charter of Bacoor,) "the Sangguniang Panlungsod has the power to regulate activities relative to the use of land, building and structures within the City to promote the general welfare."

WHEREAS, upon examination of its official records, the Sangguniang Panlungsod discovered that no development permit was issued in favor of Household Development Corporation for the development of the Camella Carson Subdivision Project located at Barangay Molino 3, Bacoor City, Cavite in clear violation of the quoted provision of law.

NOW THEREFORE, upon motion of Councilor Edwin G. Gawaran unanimously seconded by the City Council, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to pass a resolution directing the City Planning and Development Office to cause the issuance of a cease and desist order against Household Development Corporation due to its development of the Camella Carson Subdivision Project without a development permit issued by the Sangguniang Panlungsod as mandated by law.
