A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REGARDING THE PROTECTIVE SERVICES PROGRAM (PSP) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR.

WHEREAS, the Department of Social Welfare Development (DSWD) is mandated to improve the capabilities of poor, vulnerable and disadvantaged individuals, families and communities, to enable them to improve their quality of life. To achieve this, the DSWD continuously implements various social welfare and development (SWD), social protection (SP) and anti-poverty programs and projects in partnership with various intermediaries;

WHEREAS, the Protective Services Program (PSP) is part of the DSWD's protective services for poor, marginalized and vulnerable/disadvantaged individuals. The PSP has been implemented by the DSWD for decades, as part of its technical assistance and resource augmentation support to various local government units such as the City Government of Bacoor;

WHEREAS, the DSWD intends to provide financial assistance to beneficiaries residing in the City of Bacoor through the city government pursuant the parameters set under DSWD Memorandum Circular No. 04 Series of 2015 [Guidelines on the Implementation of the Protective Services Program (PSP)];

WHEREAS, fund transfer to the City Government of Bacoor is identified as a mode of payment to fast-track the distribution of cash assistance and the said funds shall be disposed by the City Government of Bacoor as financial assistance to qualified clients in accordance with the applicable DSWD guidelines and rules;

WHEREAS, a draft Memorandum of Agreement between the city government and the DSWD regarding the implementation of the PSP in the City of Bacoor pursuant to DSWD Memorandum Circular No. 04 Series of 2015 [Guidelines on the Implementation of the Protective Services Program (PSP)] was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration;

WHEREAS, after a thorough review of the said Memorandum of Agreement, the city council unanimously resolved to authorize the City Mayor to sign the said contract for and on behalf of the city
