WHEREAS, City Engineer, Robert M. San Jose forwarded to the Office of the Sangguniang Panlungsod a letter from Executive Judge, Hon. Eduardo Israel Tanguanco of the Regional Trial Court Branch 89, expressing gratitude for the magnanimous gesture of initiating the construction of a new Hall of Justice in the new Bacoor Government Center.

WHEREAS, also expressed in the said letter, is a manifestation that the parking space allotted in the proposed site will not be enough to serve the requirements of the court judges, employees and other court-users, that they are requesting that the courts and other adjunct offices to occupy the soon-to-be vacated old City Hall once the City Government transfers its offices to the New Bacoor Government Center in Bayanan, City of Bacoor, Cavite.

WHEREAS, the proposal is both beneficial and advantageous to the courts and court-users owing to the readily available parking space and buildings that need minimal renovation to comply requirements of the courts.

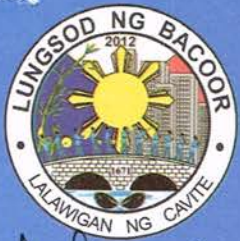
