REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF EDUCATION (DepEd) , REGION IV-A REGARDING ON THE BOTTOM-UP-BUDGETING (BUB) FOR THE PROJECT KNOWN AS "GULAYAN SA PAARALAN" FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR, CAVITE.**

**WHEREAS**, the Bottom-Up Budgeting (BUB) program of the Department of Budget and Management (DBM) primarily empowers grassroots non-government organizations and local government units (LGUs) in identifying priority poverty reduction projects that will be funded by national agencies;

**WHEREAS**, the Department of Education (DepEd) is one of the participating agencies in the implementation of Bottom-Up Budgeting (BuB) Programs;

**WHEREAS**, the City Government of Bacoor is identified as one of the recipient LGUs with approved project known as " Gulayan sa Paaralan" that is included in the DepEd's budget;

**WHEREAS**, the DepEd allotted Three Hundred Thirty Thousand Pesos (PhP330,000.00) for Bottom-Up-Budgeting (BUB) while the city government shall contribute a counterpart fund of Sixty Six Thousand Pesos (PhP66,000.00) intended for the said "Gulayan sa Paaralan" project.
