A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH (DOH) REGIONAL HEALTH OFFICE 4A (CALABARZON) REGARDING THE IMPLEMENTATION OF COMMUNITY HEALTH TEAM MOBILIZATION PROGRAM WITH AN APPROVED BUDGET OF PHP 1,200,000.00 UNDER THE BOTTOM-UP BUDGETING PROGRAM FOR CY 2015.

WHEREAS, Executive Order No. 43-S-2011, involves the organization of Human Development and Poverty Reduction Cluster (HDPRC) the Good Governance Act and Anti-Corruption Cluster (GGAC), and the Economic Development Cluster in implementing the Grassroots Participatory Budgeting Process (GPBP), previously called Bottom-Up Budgeting (BUB), of the national government.

WHEREAS, the Department of Health Central (DOH) issued Comprehensive Fund Release (CFR) for CY 2015 to the Regional Health Office No. 4A to fund priority health programs, projects and activities (PAPs) including the implementation of poverty reduction projects of the LGUs in CALABARZON under the GPBP.
