**A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT REGARDING THE IMPLEMENTATION OF THE PERFORMANCE CHALLENGE FUND.**

**WHEREAS**, the Department of Local and Interior Government (DILG) through the Bureau of Local Government and Development Goals (BLDG) is the national government agency with the primary responsibility of capacitating LGUs to effectively discharge their powers and functions towards improving the delivery of basic services and facilities to their constituents and achieve the Millennium Development Goals (MDGs) of the country.

**WHEREAS**, the Development Budget Coordinating Committee (DBCC) of the Department of Budget and Management (DBM) approved the Performance Based Incentive Policy which provides for an incentive framework to rationalize national government and intergovernmental transfers to Local Government Units (LGUs) towards improving LGU performance in governance and delivery of basic services.

**WHEREAS**, the Performance Challenge Fund (PCF) for the Local Government Unit is a flagship program of the DILG that serves as a facility that will help stimulate the LGUs that put premium on transparency and accountability to enable them to avail themselves of financial support to jumpstart and sustain local socio-economic development initiatives supportive of national government goals and priorities. It is an incentive fund to eligible LGUs to support the high-impact capital investment projects in the Annual Investment Plan (AIP).

**WHEREAS**, the Performance Challenge Fund (PCF) is being administered by the DILG with the DBM to recognize good governance performance particularly in the adoption of "good housekeeping" practices along the governance areas of development planning, sound financial agreement, transparency and accountability and in valuing performance monitoring.


**NOW THEREFORE**, upon unanimous motion, in joint session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve a resolution authorizing the City Mayor to sign and enter into a Memorandum of Agreement for and in behalf of the City Government of Bacoor with the Department of Interior and Local Government regarding the implementation of the Performance Challenge Fund.
