A RESOLUTION APPROVING THE ANNUAL INVESTMENT PLAN OF THE CITY OF BACOR, PROVINCE OF CAVITE FOR CALENDAR YEAR 2016.

WHEREAS, on 07 August 2015, the City Development Council (CDC) of the City of Bacoor passed its Resolution No. 1, Series of 2015 approving the list of priority projects and programs in the Annual Investment Plan (AIP) 2016 of the City Government of Bacoor, Province of Cavite amounting to **One Hundred Seventy Four Million Thirty Nine Thousand Five Hundred Ninety Pesos (PhP174,039,590.00)**.

WHEREAS, in compliance with the various pertinent provisions of RA 7160 and applicable government edicts and policies, the City Development Council formulated the Annual Investment Plan for Calendar Year 2016 of the City of Bacoor.

WHEREAS, the Sangguniang Panlungsod deliberated on CDC Resolution No. 1, Series of 2015 and on the proposed Annual Investment Plan for Calendar Year 2016 and unanimously voted to approve the same;

WHEREFORE, on motion of Hon. Reynaldo Palabrica unanimously seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to ratify the Annual Investment Plan for Calendar Year 2016 of the City of Bacoor.
